- VictoryFlagsAndMore.com does not sell, trade, or rent your personal information to other companies.
- The information we collect about you is used to process orders and to provide a more personalized shopping experience.

We offer the use of a secure server. All supplied sensitive/credit information is transmitted via Secure Socket Layer (SSL) technology and then encrypted into our Payment gateway providers database only to be accessible by those authorized with special access rights to such systems, and are required to keep the information confidential.

After a transaction, your private information (credit cards, social security numbers, financials, etc.) will not be stored on our servers.

### **Do we use cookies?**

Yes (Cookies are small files that a site or its service provider transfers to your computers hard drive through your Web browser (if you allow) that enables the sites or service providers systems to recognize your browser and capture and remember certain information.

### **Do we disclose any information to outside parties?**

We do not sell, trade, or otherwise transfer to outside parties your personally identifiable information. ## **Incorporation into Conditions of Use**

This privacy policy (hereinafter “**Policy**”) is incorporated in and subject to, the [Conditions of Use](#) (hereinafter “**Conditions of Use**”) for this website (hereinafter “**Site**”). Please refer to the Conditions of Use for definitions of words with initial capitals letters that are not otherwise defined in this Policy. The Site is owned by Raymond Shores and Associates, Inc. (hereinafter “**RSA**”, “**We**”, “**Us**” and “**Our**”), a for-profit Mississippi corporation.

RSA reserves the right, in Our sole discretion, to change, modify, add, or remove portions of this Policy at any time. When IB makes any significant updates to this Policy, IB will post a notice in a prominent place on our website for a period of thirty (30) days to make you aware of the changes that have been made. For ease of reference, IB will also indicate when the most recent version of the Policy took effect. By your continued use of the Site, you consent to the revised terms of our Policy. You should read this Policy periodically for changes. If you use the Site after IB posts changes to this Policy, you are deemed to have accepted the changed Policy.

## **Information Collection and Submission**

IB collects information to provide better services for all of its users. When you visit the Site, you acknowledge that you may be providing IB with two specific types of information: (i) information that you provide which personally identifies you or your business (“**Personally Identifiable Information**”) and (ii) information that you provide, or that we collect as you interact with the Site, which does not personally identify you or your business (“**Site-Use Information**”).

However, IB cannot guarantee that any electronic commerce is totally secure. For example, IB has no control over the information collected by your Internet service provider or your employer (if the Site is made available to you through your employer). ## **Permitted Disclosures**

*Affiliates*: Subsidiaries and affiliates of Interstate Batteries, Inc., and their respective employees, agents, and contractors may access and use your Information in accordance with this Policy.

*Third-Party Service Providers*: IB employs other companies and individuals to perform functions on its behalf. Examples include (i) those who help IB manage or provide the Site or process functionality offered by the Site (for example, statistical analyses, data processing, and marketing assistance), and (ii) outside contractors, agents, or sponsors who help IB with the development, administration and maintenance of the Site or process functionality offered by the Site. ## **Use of Information**

IB's use of Personally Identifiable Information and Site Use Information is a necessary part of IB's business, and IB will use information collected on the Site as described in this Policy.

*Site Use Information.* In addition to the uses described in the "Permitted Disclosures" section, IB is permitted to use the Site-Use Information in IB's discretion. Accordingly, IB reserves the right to aggregate Site-Use Information with information collected from other visitors of the Site to track overall visitor traffic patterns, which will allow IB to develop statistics that are helpful to understanding how visitors use the Site. IB may also use Site-Use Information (i) to monitor, maintain, and improve the functionality of the Site, making it more responsive to the needs of the Site's visitors, and (ii) for historical, statistical, scientific, or other purposes. ### **Modification of Personally Identifiable Information**

We will take commercially reasonable steps to correct any Personally Identifiable Information if you inform us that it is incorrect.

### **Data Retention**

IB may retain your personal information, including but not limited to your Personally Identifiable Information, as long as necessary to achieve the purpose for which it was collected. This usually will last for the duration of any contractual relationship or as thereafter legally required or permitted by law.
